I/we understand that horseback riding and related activities, such as dressage, eventing and jumping, are very dangerous and involved the risk of serious injury and/or death, and/or property damage, including injury and/or death to horses, spectators, and others. Accordingly, I/we agree that any activity engaged in, hosted by Florabama DSDCTA, by me on the premises owned by Janssen Dressage, or related to horses, or horseback riding, if on the premises, is done at my own risk. Accordingly, I/we release and agree to hold harmless Janssen Dressage and the Florabama Chapter of DSDCTA, along with its board of directors and employees, and any and all persons or entities who are guarantors or indemnitors of the above, all agents, employees, promoters, sponsors, other horse riders, horse owners, advertisers, sales persons, photographers, volunteers, (hereinafter called Releasees) from all liability for negligence or otherwise.

I/we assume full responsibility for the risk of bodily injury, illness, communicable disease, death of myself and/or my horse(s) and any property damage due to negligence of Releasees or otherwise while the premises owned by Janssen Dressage and the Florabama Chapter of DSDCTA along with its board of directors and employees or heavily engaged in horseback riding-related activities, and/or while training, riding, competing, officiating, observing, volunteering, teaching, boarding, working for, or for any purpose relating to horseback riding, dressage, eventing, jumping, or participating as rider or spectator in such activities. I/we agree not to sue any Releasees, and I/we release and agree to indemnify for the Releasees form and for all liability for the undersigned, his/her person, representatives, assignees, heirs, and demands therefore on account of injury to her person or property, or communicable disease, or death of undersigned whether caused by negligence of the Releasees or otherwise.

Florabama DSDCTA and Janssen Dressage Horse Show Stay Safe Protocol

- Pre-entries are strongly recommended. To reduce congregation in the show office, we ask that each barn send a representative to pick up show numbers and competitor packets.
- New and/or additional protocols/rules will require a new release to be signed by all participants.
- We will limit the number of people permitted in the show office at a time.
- Disinfectant will be provided at each schooling jump in the schooling area and at the in gate of the showing arenas.
- We ask that any spectators to practice social distancing.
- We encourage everyone attending the horse show to wear a mask or shield.
- In the event of a storm you will be asked to shelter in your car or space social distancing can be maintained.
- All awards will be made available at or near the show office.
- Show stabling will be separated by farm.
- Trainers will be held responsible for their barns, ensuring compliance with all rules & regulations.
- Grooming/tacking is to be done in the horse's stall or a grooming stall, not in the aisles.
- Assigned schooling times will be posted & must be followed.
- There may be a posted order of go.
- Anyone exhibiting symptoms of illness are not permitted to attend the show.
- Any individual not in compliance with these regulations will be asked to leave the grounds & not return.
- Concessions will not be available. Water will be available at the show office.
- Management reserves the right to change any rules or protocol at any time deemed necessary.
